## **Land Managers Update**

#### a. Metro

- i. Cambodia update
  - 1. James and Deanne met with Metro Vancouver/RSTBC
  - A new wooden feature was completed between two walk through without Metro Vancouver approval which led to them questioning the Cambodia sanctioning project.
  - 3. Metro requested to close the feature and request their approval before proceeding to any work not tearing down the feature as of now.
  - 4. All builders on Metro Vancouver land will be required to be affiliated with NSMBA.

#### b. District of North Van

- i. Boogie Nights update
  - DNV had some concerns and requested changes Hip gap jump was in the same line as the black line, DNV requested that the double black line requires a different line - builders agreed to the changes.
  - 2. Trail closed on the Friday work started on the Saturday.
  - 3. Consumption of alcoholic beverages on trail was discussed.
- ii. Independent builders
  - 1. DNV's risk management department wants to require that independent builders hold the same liability insurance that NSMBA holds.
  - 2. Would lead to independent builders being included under NSMBA umbrella or having to manage their own liability insurance.
  - 3. This will be a conversation coming up DNV started contacting the builders.
