# Marketing/Membership Update

- o 23 people referred, 15 memberships (65% conversion rate)
- o Email blast, instagram

- 5000 member goal by Oct 2023
  - o Need 325 new memberships per month
  - o 4000 member goal = 182 new members/month

- Total membership increased since last year
- BC Bike Show
